- Children's coalition was established in 2015 composed of Snohomish County employees. Collaboration with community providers, social services providers, education staff, health department and Snohomish County began conversations forming the coalition.
- Initial goal was to engage the community to ensure all youth in Snohomish County to be equipped with reliance. They have gone well beyond this goal.
- Coalition has the support from the county. The coalition makes decisions, but the county enacts the decision.
- Snohomish County has one of the highest youth suicide rates in the nation
- Research of other models in the country, the coalition determined to move forward into trauma informed practices in schools. Snohomish County supported the scope of practices to be implemented in schools.

- Coalition partnered with the Department of Health. A survey was created and sent out to the school districts. Based on the survey results they seen what was happening in the schools.
- Estimated 10 schools a year have entered in a contract with an organization that implements trauma informed practices in the schools.
- The goal is to have every school district and school in Snohomish County be a trauma informed school.
- Evidence based practices.
- The goal is population change and support rather than one on one. Large events that support a large population
- The first Resiliency Conference was held at Tulalip Casino and Resort. The attendance was over 500 individuals. The conference focused on the school perspective.
- Annual Family fair is where families come together with community resources.
  Range from workshops, dental vans, haircuts, family photos and family fun activities are included. The annual fair has not occurred since 2019 due to COVID.
- The greatest achievement of the coalition is developing a strong trusting relationship with agencies. The ability to share ideas and speak to the community using a common language.
- Trainings are provided
  - Secondary Traumatic Stress
  - o Youth Mental Health First Aid
  - Suicide Prevention
    - Suicide Prevention Task Force
- CARE (Compassion, Appreciation, Resilience & Empowerment) long term goal to implement trauma informed practices and policies. Principal based embodying the work.
  - o Guiding Principles
    - Peer Support
    - Safety
    - Empowerment, Voice and Choice
    - Collaboration and Mutuality
    - Cultural, Historical, Gender Issues
      - Culture competency
    - Resiliency
  - o There are 47 organizations that are CARE champions
  - A group of staff are trained. The staff begin to train the organization on trauma informed practices. The Trauma Informed Leadership Team (TILT) is developed. The team is what drives the practices to systematize it into the organizations mission, vision and values. Training is based on evidence not on speculation.
    - Trauma 101
    - Restorative Practice
    - Equity
  - A yearlong learning collaborative to continue to support the care champions.
  - A common language and understanding are used so everyone knows what trauma informed care is and what it means.
  - o The model is annually refined based on the needs of the organizations.

- Not looking for experts but for champions that are willing to learn and teach and talk about what is needed.
- Not only to train organizational staff but staff that has interaction with family and youth in the office. Train everyone from to the security guard.
